6. Accidental release measures

Personal precautions, protective equipment and emergency procedures Keep unnecessary personnel away. Many gases are heavier than air and will spread along ground and collect in low or confined areas (sewers, basements, tanks). Wear appropriate protective equipment and clothing during clean-up. Avoid breathing gas. Emergency personnel need self-contained breathing equipment. Ventilate closed spaces before entering them. Methods and materials for containment and cleaning up

Prevent product from entering drains. Cover with plastic sheet to prevent spreading. Absorb in vermiculite, dry sand or earth and place into containers.

7. Handling and storage
